(fixed) chargeable to the existing **budget provision of Rs. 80,00,000/- for 20 Research Scholarship of the value of Rs. 1000/- p.m. (fixed) for M.Phil courses at page 46, Budget Head "Miscellaneous Teaching" of the Budget Estimate (Part-I, 2020-21)** provided the candidate has been attending the classes regularly and does not get re-appear in the 1<sup>st</sup> Semester Examination (a separate Certificate to this effect is to be supplied by concerned Chairperson/Director of the Department).

The Chairperson/Director of the above Teaching Departments may please send merit list of all the M. Phil. Students admitted in the Department along with necessary recommendations by a Committee consisting of the Chairperson/Director and two senior most faculty members of the Department concerned for the award of one M. Phil. Scholarship each on the basis of the criteria mentioned above for the approval of the Hon'ble Vice Chancellor.
